Sub: Maintenance of Norms and Standards, database website, Joint Account Fixed Deposit Receipts etc., by the teacher education institutions recognised by SRC, NCTE – regarding.

Ref: Code No. APS0_____

With reference to the above, the NCTE has taken up a task of compilation of database of all the recognised institutions under the jurisdiction of SRC. In this regard proforma has been developed and enclosed.

The institutions are expected to fill up the columns without leaving any details as sought for in the proforma.

The details collected from the management will be hosted in the website of SRC for the use of general public and aspiring teacher educators. The information provided should be authentic and the provided information found to be false / concealing / misleading the Regional Committee will be viewed seriously and action against such institutions will be initiated under Section 17 of NCTE Act for withdrawal of recognition.

All the institutions are expected to maintain the endowment fund of Rs.5.00 lakhs and reserve fund of Rs.3.00 lakhs per course per unit in the joint account with SRC i.e. the institution and the Regional Director, SRC, NCTE jointly for a duration of 60 months / 5 years in Nationalised Bank. **Henceforth, the original Fixed Deposit Receipts pertaining to Endowment fund and Reserve fund will be maintained by the office of SRC. All institutions are requested to submit the original Fixed Deposit Receipts to the office** along with the filled in proforma. Any institution failing to submit the deposit receipts as above, the recognition to such institutions will be withheld with effect from the session 2009-2010 itself. A due acknowledgement will be issued for submission of Fixed Deposit Receipts with SRC. Concerned State Government Education departments like Centralised Admission Cell, EDCET, DTER, SCERT, affiliating Universities are being informed not to allot seats for such defaulting institutions those who have primarily not maintained the Endowment fund and Reserve fund. The acknowledgement provided by SRC, NCTE in original will be authentic proof for the institution to submit for the affiliating / State authorities for making admissions for the session 2009-2010. Hence all the institutions shall submit the original Fixed Deposit Receipts and obtain original acknowledgement receipts from the office of SRC through post. Government and Government aided institutions are exempted from maintaining Endowment fund and Reserve Fund.

PUBLIC NOTICE

The National Council for Teacher Education is a statutory body that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 73 of 1993) on the 17th August, 1995 to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of Norms and Standards in the teacher education system and for matters connected therewith.

2. As part of one of the conditions of recognition, NCTE insists on submission of a Performance Appraisal Report annually which includes annual statement of accounts duly audited by a Chartered Accountant. Similarly, in section 12(j) & (k) of the NCTE Act, 1993, the following is mandated -

“(j) examine and review periodically the implementation of the norms, guidelines and standards laid down by the Council, and to suitably advise the recognised institutions;

(k) evolve suitable performance appraisal system, norms and mechanism for enforcing accountability on recognised institutions;”

Furthermore, Section 17 of the NCTE Act, 1993 stipulates as under:-

“17(1) Where the Regional Committee is, on its own motion or on any representation received from any person, satisfied that a recognised institution has contravened any of the provisions of this Act, or the rules, regulations, orders made or issued thereunder, or any condition subject to which recognition (emphasis supplied) under sub-section (3) of section 14 or permission under sub-section (3) of section 15 was granted, it may withdraw recognition of such recognised institution, for reasons to be recorded in writing:.....”

3. Therefore, all Teacher Education Institutions running NCTE recognised Teacher Education Courses are required to annually file a Performance Appraisal Report which is required for regulatory examination of the physical infrastructure, teaching faculty and other stipulations as per NCTE rules, regulation or the NCTE Act.

4. The Performance Appraisal Report (PAR) is now required to be mandatorily submitted by all TEIs online on the specially designed portal (<http://ncte.gov.in/Website/PARsystem.aspx>). PAR should be submitted for the

“NCTE has been made aware that the Performance Appraisal Report (PAR) is not properly monitored by the TEIs's. Since, filing of PAR along with audited accounts report is invariably a condition of recognized , thereby all TEIs running NCTE recognized courses must fill the online portal before 31/12/2019.”

It is inform to you that Performance Appraisal Report System (PAR) has been launched on 23rd September 2019 to evaluate the performance of recognized TEIs situated the across the country. Public notice in this regard is attached with this communication.

Therefore, all Teacher Education Institutions running NCTE recognised Teacher Education Courses are required to annually file a Performance Appraisal Report which is required for regulatory examination of the physical infrastructure, teaching faculty and other stipulations as per NCTE rules, regulation or the NCTE Act.

The Performance Appraisal Report (PAR) is now required to be mandatorily submitted by All TEIS online on the specially designed portal (<http://ncte.gov.in/Website/PARsystem.aspx>). PAR should be submitted for the academic year 2018-2019 through online method and make necessary payments as under:

- (i) Central and State Govt. institutions are required to pay Rs 5000/- per institution, regardless of number of courses being run.
- (ii) All other categories to pay Rs. 15000/- per institution, regardless of number of courses being run.

Timeline to submit the online PAR shall be from 23 September 2019 to 31st December 2019(mid night).

Non-submission of PAR will attract action under section 17(1) of NCTE Act, 1993.

FOR ON-LINE PAR FORM

General Instructions:

1. The applicants are requested to read the following instructions/documents carefully, before filling online application: -
 - a) NCTE Act 1993
 - b) NCTE Regulations, 2014 (Recognition Norms and Procedures), as amended from time to time
 - c) Public Notice related to Performance Appraisal Report (PAR) System.
2. **No user can register more than once on the site.** Please note that once you register yourself on the NCTE website, you are deemed to have agreed to the terms and conditions set forth below. If you do not agree with all these terms and conditions, you must not transact on this Website. **Once you have clicked the 'I Agree' buttons at the bottom of these Terms and Conditions page, you have entered into a formal agreement with NCTE for the purpose of terms & conditions and transactions on this website.**
3. In case of self-financed educational institutions established and operated by "not for profit" societies and trusts, registered under the appropriate laws or a company incorporated under the Companies Act, 2013, will register themselves under the respective Societies/Trusts/Companies and not as an Independent Institute.
4. For independent educational institutes or universities, established or financed by Government (including institutions deemed to be universities), they will get registered as institutes/universities, as the case may be.
5. **Please follow the STEPS determined for filing Online PAR.**
6. **The web link to fill up online PAR will remain active from 23rd September 2019 to 31st December, 2019 (till 11.59 P.M.).** Institutions are advised to fill the online PAR well in time/advance, without waiting the last date of applying to avoid any network congestion/hassle. **NCTE shall not be responsible for any last date network error.**
7. Applicants are advised to provide/fill correct and complete details, as this information will get recorded and will be used for further evaluation, communication and references.
8. **Applicants are advised to keep all relevant documents (including Society/Trust/Company Registration Certificate (If applicable), Land Details**

Certificate and Building Completion Certificate and other documents etc., ready before starting with the form filling process.

9. Applicants are advised to apply for PAR system from their institution's computer/ICT Lab, as IP address of the computer shall be recorded.
10. Applicants are advised to connect their computing devices to a proper network with stable internet bandwidth/ or by moving to a better Wi-Fi spot, if using a mobile computing device.
11. The registration process is the one-time activity and the system will not allow for multiple registration with the same credentials. If attempted for getting registered for the same Society/Institute, the system will reply "User Already Exist"
