Decision of SRC in its 387th meeting held on 24th - 25th August, 2020 - regarding.

Sir,

The Southern Regional Committee (SRC) In its 387th meeting held on 24th-25th August, 2020 decided the following:-

"... The SRC discussed the issue of institution offering Teacher Education programmes without obtaining recognition from the NCTE. In this regard, the Regional Director, SRC, NCTE is advised to write a letter to the Secretary, Education & Director, SCERT of the State / UT in the jurisdiction of Southern Regional Committee to provide the list of such institution in their respective State / UT (if there are any). This may be treated as most urgent."

On the aforesaid matter, the following instances comes to the notice of the SRC, NCTE which need appropriate action on your part:-

(i) It has come to the knowledge of SRC, NCTE that State Govt., certain State Universities and State Education Councils has given permission to the educational institutions for running teacher education programme without obtaining recognition from the NCTE which is compulsory mandated by the NCTE Act, 1993.

(ii) It has also come to the knowledge of SRC, NCTE, that there are certain fake and unrecognized educational institutions who are imparting teacher education programme without obtaining recognition from the NCTE. It is requested that appropriate action may be taken in accordance with law against those institutions and same may also be intimated to SRC, NCTE.

(iii) The SRC also noticed that even some of the recognized institutions are taking additional intake of students/course for which they have not been given recognition/permission by the SRC, NCTE. The institutions has also submitted fake recognition/permission of additional intake/course to the aff/liating bodies and affiliating bodies have been giving aff/siation on the basis of fake/forged orders of the SRC, NCTE.

Regarding point No. (i), it is bring to your kind notice that as per National Council of Teacher Education (NCTE) Act 1993, the NCTE is Apex body of Government of India enacted by an Act of Parliament to accord recognition / permission to the teacher training institution in the Country. It is also brought to the attention of your good self about the provision of Section 17(4) of NCTE Act:-

The information provided should be authentic and the provided informatio found to be false / concealing / misleading the Regional Committee will be viewed seriously and action agains such institutions will be initiated under Section 17 of NCTE Act for withdrawal of recognition.

All the institutions are expected to maintain the endowment fund of Rs.5.00 lakes and reserve fund of Rs.3.00 lakhs per course per unit in the joint account with SRC i.e. the institution and the Regional Director, SRC NCTE jointly for a duration of 60 months / 5 years in Nationalised Bank. Henceforth, the original Fixed Depos Receipts pertaining to Endowment fund and Reserve fund will be maintained by the office of SRC. A institutions are requested to submit the original Fixed Deposit Receipts to the office along with the filled i proforma. Any institution failing to submit the deposit receipts as above, the recognition to such institutions will b withheld with effect from the session 2009-2010 itself. A due acknowledgement will be issued for submission ( Fixed Deposit Receipts with SRC. Concerned State Government Education departments like Centralise Admission Cell, EDCET, DTERT, SCERT, affiliating Universities are being informed not to allot seats for suc defaulting institutions those who have primarily not maintained the Endowment fund and Reserve fund. The acknowledgement provided by SRC, NCTE in original will be authentic proof for the institution to submit for the affiliating / State authorities for making admissions for the session 2009-2010. Hence all the institutions sha submit the original Fixed Deposit Receipts and obtain original ackowledgement receipts from the office of SR Submit the original rived Deposit Receipts and Sold and State State and Sold and State of Sk through post. Government and Government aided institutions are exempted from maintaining Endowment fur and Reserve Fund.
