# ANNEXURE GUIDELINES FOR ADMISSION TO B.Ed. DEGREE PROGRAMME-Duration : Two years course 2018-2020

(Government / Government Aided / Self-Financing Colleges of Education)

#### I. Major Subjects offered under B.Ed. Degree Programme:

1. The following Major subjects are offered under B.Ed. Degree Programme in Government/Government Aided/Self-Financing Colleges of Education.

i)Subject Codes 01 to 10: As these subjects are taught in the High School level, the requisite qualifications for admission to these subjects is UG Degree in the relevant subject with not less than the percentage of marks stipulated in Item II (ix) herein. The minimum % of marks stipulated in Item II (ix) herein shall not be applicable to the candidate those who are having PG Degree in the same subject with not less than 50% of marks. But, the weightage of marks given in clause V 2(i) (a) herein is not applicable for such candidates and the marks scored UG degree alone will be taken to arrive rank.

ii) **Subject Codes 11 to 19**: The requisite qualifications for admission to these subjects is PG Degree in the relevant subject with not less than 50% of marks, subject to the condition that the major subject in the UG and PG Degrees shall be one and the same.

iii)**Subject Codes 14 to 19:** The subjects indicated in these subject codes and Urdu are not offered by the Government and Government Aided Colleges of Education.

2. Actual Major subjects offered in each college and number of seats available will be notified in the DCE website or at the Counselling Centre.

#### II. Eligibility and Educational Qualification:

(i) (a) Candidates with at least fifty percent marks either in the Bachelor's Degree and/or in the Master's Degree in Sciences/Social Sciences/Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme.

(b) The candidates should have undergone 10+2+3(15) or 11+1+3(15) pattern of study and passed the qualifying examination conducted by the respective State Board or CBSE or any other recognized Board of Education / Examination and UG Degree Examination of the UGC recognized Universities in any one of the school subjects offered by the Directorate of School Education at the Secondary/ Higher Secondary Education level.
(c) The state the school State State

(C) The three year Diploma in Engineering shall be treated as equivalent to +2 course for the purpose of eligibility for admission.

(ii) Candidates, who have passed the UG or PG degree under Open University System without qualifying in 11 years SSLC examination and one year of Pre-University Course (P.U.C) examination or 10+2 pattern of School Education examination are not eligible for admission, even if they subsequently qualify in 11year SSLC and one year PUC or 10+2 pattern of School Education Examination.

(iii) Candidates, who have taken more than one main subject in Part III & Part IV (under Double/Triple Major System) of UG degree course should have to choose only one of the main subjects and should have applied for that Major only. In such cases, marks obtained by the candidates in two/three major subjects shall be taken into account to arrive at the percentage of marks as stipulated in item (ix) herein. (iv)Candidates, who have passed any degree under Additional Degree Programme or lateral entry mode with less than three years duration are not eligible for admission.

(v)Candidates, who have passed under four year Dual Degree Programme with two major subjects under Part III are not eligible for admission.

(vi)Candidates, who have qualified the P.G. Degree in the subjects in Subject Codes 11 to 19with not less than 50% of marks are eligible for admission, subject to the condition that the major subject in the UG and PG Degrees shall be one and the same.

(vii) Candidates, who have qualified the P.G. Degree (5 year integrated course) under 10+2+5 or 11+1+5 pattern of study shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years (in major and ancillary or allied subjects alone) of the course alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4th& 5th year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.

#### (Viii) Equivalent Subjects:

- a) Candidates, who have done their UG degree in Applied Mathematics can apply for Mathematics.
- b) Candidates, who have done their UG degree in Applied Physics, Geo-Physics, Bio-Physics and Electronics can apply for Physical Science.
- c) Candidates, who have done their UG degree in Applied Chemistrycan apply for Physical Science.
- d) Candidates, who have done their UG degree in Bio-Technology, Plant-Biology and Plant Bio-Technology can apply for Biological Science.
- e) Candidates, who have done their UG degree in Environmental Science and Micro-Biology can apply for Biological Science.
- f) Candidates, who have done their UG degree in Applied Geography can apply for Geography.
- g) Candidates, who have done their UG degree in Computer Science, Information Technology and Computer Application can
   apply for Computer Science.

- h) Post Graduate candidates in Economics, Commerce, Home Science, Political Science, Sociology, Psychology, Philosophy, Logic and Indian Culture with not less than 50% (irrespective of their UG marks) of marks in PG Degree or in the interdisciplinary subjects, which are being declared equivalent by the respective University can apply.
- i) Candidates, who have done their PG degree in Nutrition and Dietetics are eligible to apply for Home Science.
- j) Candidates, who have done their UG degree in the school subjects (Subject Code 1 to 10) are eligible for admission to B.Ed. However, those who have done the UG in the subjects for which equivalence is not covered under this G.O., shall have to obtain an equivalence certificate for the respective subjects from the concerned University to consider their admission to B.Ed. degree programme.
- k) Candidates, who have done their UG level without language Tamil or other Indian Languages under Part-I and are awarded
  degree with English and Main subjects concerned will be considered for admission to B.Ed. subject to the condition that they have to qualify in Tamil Language Test conducted by the TNPSC for the purpose of employment.

l) Candidates with at least fifty five percent marks either in the Bachelor's Degree in Engineering or Technology with specialization in Science and Mathematics are eligible for admission to the two year B.Ed., degree programme. All the B.E./B.Tech./M.E./M.Tech., graduates irrespective of their Branch in Engineering are eligible to study either Mathematices or Physical Science as Pedagogy of a School Subject. Apart from. the B.E./B.Tech./M.E./M.Tech., graduates in Computer Science related branches and Bio-Technology related branches are also eligible to study Computer Science and Biological Science as Pedagogy of a School Subject respectively.

M) Candidates who have passed Bachelor's Degree in Engineering with not less than 3 years of duration under lateral entry are also eligible for admission.

(ix) Candidates, with the following marks in the UG Degree are eligible for admission to B.Ed. degree programme with the subjects in Subject Codes 01 to 10. The marks obtained in UG Degree alone shall be taken to arrive the rank even if they possess PG Degree in the same subject. For the subjects in Subject Codes 11 to 19, PG Degree with not less than 50% marks is mandatory and the subject in UG and PG shall be one and the same.

a) Marks obtained by the candidates in the UG Degree Course Part-III & IV Major and Allied including Practical *[Tamil/Urdu, English, Mathematics, Physical Science(Physics), Physical Science(Chemistry), Biological Science(Botany), Biological Science(Zoology), History, Geography and Computer Science | alone shall be taken into account to arrive at the percentage of marks mentioned above. Marks obtained under Part-V subjects shall not be taken into account to arrive at the percentage of marks. If the candidates possess PG degree in these subjects, weightage of marks will be given as mentioned herein under item V 2 (i) only for arriving rank.* 

- b) Marks obtained by the candidates in the PG Degree [Home Science, Economics, Commerce, Political Science, Sociology, Psychology, Logic, Indian Culture and Philosophy] shall be considered eligible for admission and weightage marks will be given as mentioned herein under item V 2 (i)'.
- c) To arrive at above percentage of marks, the marks obtained by the candidates in Major / Ancillary / Allied subjects (Part III & IV) including practical alone shall be taken into account.
- d) For the students who have done their Bachelors Degree in Engineering or Technology, the marks obtained in their Degree shall be taken into account.
- e) Rounding of marks to the next higher integer shall not be permitted.
- f) The candidates who are qualified in UG degree under Open University System after passing 10<sup>th</sup> Std. and +2 examinations shall alone be considered for admission to B.Ed. degree programme.

g) The candidates who are qualified in UG degree under Open University System without passing 10<sup>th</sup> Std. and +2 examinations and subsequently passing 10<sup>th</sup> and +2 examinations are not eligible for admission to B.Ed. degree programme.

(x) Candidates, who have passed PG degree in Economics, Commerce, Home Science, Political Science, Sociology, Psychology, Philosophy, Logic and Indian Culture without undergoing 10+2+3 or 11+1+3 pattern of education are not eligible for admission.

(xi) In the case of Differently abled (Physically and Visually challenged) candidates, a minimum pass in the requisite qualification is enough.

The basis of selection shall be in accordance with the Regulations of the University / Government of Tamil Nadu Guidelines for admission to B.Ed. degree programme in force from time to time.

#### III. Reservation of Seats:

- 1. Reservation of seats for candidates belonging to BC, MBC/DNC,SC and ST communities will be made as per the rules and regulations of the Government of Tamil Nadu, as follows.
  - a. 15% for Scheduled Castes (SC) and 3% of Scheduled Castes Arunthathiyars (SCA)
  - b. Scheduled Tribes (ST) 1%
  - c. Most Backward Classes (MBC) and Denotified Communities (DNC) 20%
  - d. 26.5% of Backward Classes (BC) other than Backward Classes Muslims and 3.5% of Backward Classes Muslims (BCM) and
  - e. Open Competition (OC) 31%
- 2. Admission to every College of Education shall be made strictly by following the rule of reservation as per law in force including the Management quota seats of Non-Minority Aided Colleges.
- 3. For the Wards of Ex-Servicemen of Tamil Nadu origin, one seat will be reserved in each College of Education.
- 4. 5% of the sanctioned strength will be reserved for Differently abled (Physically and Visually challenged) students in each College of Education. Additionally, 5 seats are exclusively allotted for Visually Challenged candidates in each of the two IASEs and five Government Colleges of Education.

# IV. Selection and Admission Procedure under Single Window Counselling System:

a) Allocation of seats in the Colleges of Education.

Scats in the Colleges of Education are grouped into the following categories.

- i. Seats in Government Colleges of Education (100% of seats Government quota)
- Seats in Government Aided Colleges of Education (50% of seats in Aided Minority Colleges and 90% of seats in non-minority Aided Colleges as Government quota)

## b) Method of Application.

- Accurate information about the percentage of marks is essential. The candidate is totally responsible for any incorrect information and incorrect percentage of marks.
- Candidates are advised to take a Xerox copy of the coding sheet and fill up all the information correctly before filling the original coding sheet.
- iii) A candidate needs to submit only one application for B.Ed., Course seeking admission to Government, Government Aided Colleges of Education. The cost of application is Rs. 500/- In the case of SC/ST candidates the cost of application is Rs. 250/- on production of attested Xerox copy of the Community Certificate. The cost of application must be paid either in cash or in the form of Demand Draft drawn from any Nationalised Bank / Scheduled Bank in favour of "The Secretary, Tamil Nadu B.Ed. Admission, Chennai", payable at Chennai.

#### c) Last Date.

- 1. i) Last date for receiving the filled-in application in person or by post will be notified in the advertisement.
  - ii) Application not received on or before the due date, not in the prescribed form, not correctly filled up or do not otherwise fulfill the terms of the instructions will be considered defective and are liable for rejection without notice. The candidates alone is responsible for any delay in receipt of application sent by post. No correspondence will be entertained in this respect.
  - iii) Candidates will have to produce all the Original Certificates at
  - the time of counselling for verification and admission or at any other time as required by the authorities. Selection will not be

made if they produce the relevant documents at the time of counselling for verification.

- 2. i) The Candidates belonging to Tamilnadu only will be considered for communal reservation. Candidates seeking admission against SC, SC Arunthathiyars ST/MBC/DNC/BC Muslim, BC others quota should obtain the Certificate of Social Status in the prescribed permanent Community Certificate / Card of Tamilnadu and that should be produced at the time of Counselling.
  - ii) The ST candidates should obtain the Community Certificate only from the Revenue Divisional Officer (RDO) of their native place or Collector of their District.
- Candidates have to send the filled in applications (coding sheetas loose sheet) along with the xerox copies of all mark sheets, ~ Co-Curricular Activity Certificates and Community Certificate to "The Secretary", Tamilnadu B.Ed Admissions. Lady Willingdon Institute of Advanced Study in Education, Chennai -600 005."

#### d) Selection and Counselling

- 1. The Selection of candidates will be on the basis of the marks secured in the qualifying UG/PG Degree examination.
  - 2. i) Candidates will be called for counselling in the order of their rank. Based on the rank and communal reservations, allotment will be made to the college and optional subjects that are available in the respective college at the time of counselling. Candidates other than SC/ST have to submit a Demand Draft for Rs. 2000/- and Rs. 1000/- in case of Tamilnadu SC/ST candidates as "Initial Payment" drawn in favour of "The Secretary, Tamil Nadu B.Ed. Admission, Chennai", at the time of counselling. Candidates should produce all original certificates when they come for counselling.
    - ii) Once the candidate is allotted a seat, the amount of Rs. 2000/for other communities and Rs. 1000/- in case of SC/ST in (Tamilnadu) already paid at the time of Counselling will be adjusted towards the tuition fees that has to be paid to the respective allotted college.
    - iii) Any Change in the allotment place is requested by the candidate, she/ he has to pay Rs.200/- as processing fee for each change.

- 3. i) The date, time and venue of the counseling will be intimated to the individual candidates by post and through the press / media. No request for change of date/time of counselling is permissible.
  - ii) Candidate will not be considered for selection if he/she fails to(i) report at the specified time and date for counselling, (ii) bring all the certificates in original.
  - iii) The candidates have to join the colleges to which they are allotted within the time notified in the Admission order, failing which, the seats will be deemed to have fallen vacant. No request for reconsideration of admission thereafter shall be entertained.
- 4. The provisionally selected candidates in the counselling will be directed to report for admission to the institution specified in the admission order. Candidate has to report within the specified date with all the certificates in original and must be ready to remit the fees as directed in the allotted college.
- The provisional selection of the candidate will be cancelled, if hc/shc fails toi)report within the specified time limit at the allotted college, ii) produce original certificates, iii) remit the fees required to be paid at the college and such allotted seat will be filled by other candidates as per ranking list.

#### V. Rank Listing:

- 1. i) The percentage of marks obtained by the candidate in major and ancillary or allied subjects (both in theory and practical) in all three years in the UG degree will be taken as the base mark for ranking for subject codes 01 to 10.
  - ii) Candidates, who have taken more than one main subject in Part III (under Double/Triple major system) of UG Degree programme(Subject Codes 01 to 10) should have to choose only one of the main subjects and should have applied for that optional subject only. In such cases, marks obtained by the candidates in Two/Three major subjects shall be taken into account to arrive percentage of marks as stipulated in item II (ix).
  - iii)The percentage of marks obtained by the candidates in the P.G. Degree will be taken as the base mark for ranking for the Subject Codes 11 to 19, subject to the condition that the major subject in the UG and PG Degrees shall be one and the same.

- iv) Candidates, who have qualified in the P.G. Degree (5 year integrated course) under 10+2+5 or 11+1+5 pattern of study shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years (in major and ancillary or allied subjects alone) of the course alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4th& 5th year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.
- v) In case of determination of inter-se-merit of candidates with the same marks in the ranking, final ranking of candidates will be declared from the following, in the order of merit.
  - a. Marks scored by the candidate in the Major subject. -
  - b. Marks scored in Allied-I subject
  - c. Marks scored in Allied-II subject
  - d. By random method
- vi)Common and community wise rank list shall be maintained to each optional subject separately.
- 2. i) Weightage for the highest qualification in relevant subject will be given as follows and added to the base mark for Ranking. However minimum marks mentioned in the Item II (ix) is mandatory for subject codes 01 to 10 and not less than 50% of marks for subject codes 11 to 19.

ii) The higher qualification for which weightage will be given should be in the same subject studied as the main subject in Part III of the UG Degree and preferred as optional subject in the B.Ed. Programme.

iii) Weightage of 3 (three) marks for participation in any one of the following co-curricular activities will be added.

- a. NSS Certificate [with two years enrolment in NSS and with minimum seven days participation in the Special Camp at College (UG degree) level alone will be considered]
- b. NCC [B or C Certificate at college (UG degree) level]
- c. Sports (should have represented the college (UG degree) at University/State/National level)

# VI. Important Instructions:

The details provided by the candidates for admission shall be accurate based on the original certificates available with them. The candidate is totally responsible for any incorrect information and incorrect percentage of marks and such cases shall be summarily rejected.

# VII. Physical Fitness Certificate:

Candidates selected will have to submit a certificate of physical fitness obtained from a Government Grill Surgeon / Grill Assistant Surgeon within the specified date, otherwise his/her selection will be cancelled.





# I. Major Subjects offered under B.Ed. Degree Programme

1. The following Major subjects are offered under B.Ed. Degree Programme in Government/Government Aided/Self-Financing Colleges of Education.

i) Subject Codes 01 to 10: As these subjects are taught in the High School level, the requisite qualifications for admission to these subjects is U.G. Degree in the relevant subject with not less than the percentage of marks stipulated in Item II (ix) herein. The minimum Percentage of marks stipulated in Item II (ix) herein shall not be applicable to the candidates those who are having P.G. Degree in the same subject with not less than 50% of marks. But, the weightage for higher qualification given in clause V 2(i) (a) herein is not applicable for such candidates and the marks secured in P.G. Degree alone will be taken to arrive at rank.

- ii) **Subject Codes 11 to 19:** The requisite qualification for admission to these subjects is P.G. Degree in the relevant subject with not less than 50% of marks, subject to the condition that the major subject in the U.G. and P.G. Degree shall be one and the same.
- iii) Subject Codes 14 to 19: The subjects indicated in these subject codes and Urdu are not offered by the Government and Government Aided Colleges of Education.
  - 2. Actual Major subjects offered in each college and number of seats available will be notified in the Directorate of Collegiate Education website or at the Counselling Centre.

### II. Eligibility and Educational Qualification

 (a) Candidates with at least 50% of marks either in the Bachelor's Degree and/or in the Master's Degree in Sciences/Social Sciences/Humanity are eligible. Bachelor's Degree in Engineering or Technology with specialization in Science and Mathematics with 55% marks are also eligible for admission to B.Ed Degree programme.

(b) The candidates should have undergone 10+2+3(15) pattern of study and passed the qualifying examination conducted by the respective State Board or C.B.S.E. or any other recognized Board of Education / Examination and U.G. Degree Examination of the U.G.C. recognized Universities in any one of the school subjects offered by the Directorate of School Education at the Secondary/ Higher Secondary Education level.

(c) The three year Diploma in Engineering shall be treated as equivalent to +2 course for the purpose of eligibility for admission.

- ii. Candidates, who have passed the U.G. or P.G. Degree under Open University System without 10+2 pattern of School Education examination are not eligible for admission.
- iii. Candidates, who have taken more than one major subject in Part III & Part IV (under Double/Triple Major System) of U.G. degree course should have to choose only one of the major subjects and should have applied for that Major subject only. In such cases, marks obtained by the candidates in two/three major subjects shall be taken into account to arrive at the percentage of marks as stipulated in Item (ix) herein.

- iv. Candidates, who have passed any degree under Additional Degree Programme or lateral entry mode with less than three years of duration are not eligible for admission.
- v. Candidates, who have passed under four year Dual Degree Programme with two major subjects under Part III are not eligible for admission.
- vi. Candidates, who have qualified in the P.G. Degree in the subjects in Subject Codes 11 to 19 securing less than 50% of marks are not eligible for admission, subject to the condition that the major subject in the U.G. and P.G. Degrees shall be one and the same.
- vii. Candidates, who have qualified in the P.G. Degree (5 year integrated course) under 10+2+5 pattern of study shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years in Part III and Part IV alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4th & 5th year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.

#### viii. Equivalent Subjects

- a) Candidates, who have done their U.G. degree in Applied Mathematics can apply for Mathematics.
- b) Candidates, who have done their U.G. degree in Applied Physics, Geo-Physics, Bio-Physics and Electronics can apply for Physical Science.
- c) Candidates, who have done their U.G. degree in Applied Chemistry can apply for Physical Science.
- d) Candidates, who have done their U.G. degree in Advanced Zoology, Bio-Technology, Plant-Biology and Plant Bio-Technology can apply for Biological Science.
- e) Candidates, who have done their U.G. degree in Environmental Science and Micro-Biology can apply for Biological Science.
- f) Candidates, who have donc their U.G. degree in Applied Geography can apply for Geography.
- g) Candidates, who have done their U.G. degree in Computer Science, Information Technology and Computer Application can apply for Computer Science.

- h) Candidates, who have done their P.G. degree in Nutrition and Dietetics are eligible to apply for Home Science.
- i) Candidates, who have done their U.G. degree in the school subjects (Subject Code 01 to 10) are eligible for admission to B.Ed. However, those who have done the U.G. in the subjects for which equivalence is not covered under the G.O. are not eligible for admission.
- j) All the B.E./B.Tech. graduates irrespective of their Branch in Engineering/Technology are eligible to study either Mathematics or Physical Science as Pedagogy of a School Subject. However the B.E./B.Tech. graduates in Computer Science related branches and Bio-Technology related branches are also eligible to study Computer Science and Biological Science as Pedagogy of School Subject respectively. The reservation of seats for the graduates in B.E./B.Tech. in each Pedagogy of School Subjects (viz. Mathematics, Physical Science, Biological Science & Computer Science) shall be 5% only.
- k) Candidates who have passed Bachelor's Degree in Engineering with not less than 3 years of duration under lateral entry are also eligible for admission.
- ix. Candidates, with the following marks in the U.G. Degree are eligible for admission to B.Ed. degree programme with the Subject Code 01 to 10. The marks obtained in U.G. Degree alone shall be taken to arrive at the rank even if they possess P.G. Degree in the same .subject. For the subjects with Subject Code 11 to 19, P.G. Degree with not less than 50% marks is mandatory and the subject in U.G. and P.G. shall be one and the same.

a) Marks obtained by the candidates in the U.G. Degree Course in Part-III & IV [Tamil/Urdu, English, Mathematics, Physical Science (Physics), Physical Science (Chemistry), Biological Science (Botany), Biological Science (Zoology), History, Geography and Computer Science] alone shall be taken into account to arrive at the percentage of marks mentioned above. If the candidates possess higher degree in these subjects, weightage for the highest qualification will be given as mentioned herein under Item V 2 (i) only for arriving at rank.

- b) Marks obtained by the candidates in the P.G. Degree [Home Science, Economics, Commerce, Political Science, Sociology, Psychology, Logic, Indian Culture, and Philosophy] shall be considered eligible for admission and weightage for the highest qualification will be given as mentioned herein under Item V 2 (i).
- c) For the students who have done their Bachelors Degree in Engineering / Technology, the marks obtained in their Degree shall be taken into account.

- d) Rounding of marks to the next higher integer shall not be permitted.
- e) The candidates who are qualified in U.G. degree under Open University System after passing 10<sup>th</sup> Std. and +2 examinations shall alone be considered for admission to B.Ed. degree programme.
- f) The candidates who are qualified in U.G. degree under Open University System without passing 10<sup>th</sup> Std. and +2 examinations and subsequently passing 10<sup>th</sup> Std. and +2 examinations are not eligible for admission to B.Ed. degree programme.
- (x) In the case of Differently abled (Physically and Visually challenged) candidates, a minimum pass in the requisite qualification is enough.

The basis of selection shall be in accordance with the Regulations of the University / Government of Tamil Nadu Guidelines for admission to B.Ed. degree programme in force from time to time.

#### III. Reservation of Seats

- 1. Reservation of seats for candidates belonging to BC, MBC/DNC, SC and ST communities will be made as per the rules and regulations of the Government of Tamil Nadu, as follows:
  - (a) 15% for Scheduled Castes (SC) and 3% for Scheduled Castes Arunthathiyars (SCA)
  - (b) 1% for Scheduled Tribes (ST)

- (c) 20% for Most Backward Classes (MBC) and Denotified Communities (DNC)
- (d) 26.5% for Backward Classes (BC) and 3.5% for Backward Classes Muslims (BCM)
- (e) 31% for Open Competition (OC)
- 2. Admission to every College of Education shall be made strictly by following the rule of reservation as per law in force including the Management quota seats of Non-Minority Aided Colleges.
- 3. For the Wards of Ex-Servicemen of Tamil Nadu origin, one seat will be reserved in each College of Education.
- 4. 5% of the sanctioned strength will be reserved for Differently abled (Physically and Visually challenged) students in each College of Education. Additionally, 5 seats are exclusively allotted for Visually Challenged candidates in each of the two IASEs and five Government Colleges of Education.
- 5. Allocation of seats in the Colleges of Education are grouped into the following categories:
  - (i) Seats in Government Colleges of Education (100% of seats Government quota)
  - (ii) Seats in Government Aided Colleges of Education (50% of seats in Aided Minority Colleges and 90% of seats in non-minority -Aided Colleges as Government quota)

## IV. Selection and Counselling

- 1. The Selection of candidates will be done purely on merit basis.
- (i) The date, time and venue of the counselling will be published in the website/press/media. No request for change of date/time of counselling is permissible.

(ii) Candidate will not be considered for selection if he/she fails to report at the specified time and date for counselling with all the certificates in original.

 At the time of counselling the candidates belonging to OC/BC/MBC/DNC category have to submit a Demand Draft for Rs. 2000/- and SC/ST category for Rs.1000/- as counselling fee. The DD should drawn in favour of "The Secretary, Tamil Nadu B.Ed. Admission, Chennai'. This amount will be adjusted towards the tution fee.

4. The provisionally selected candidates have to join the allotted college within the date notified in his/her admission order, failing which his/her allotment will be cancelled and the seat will be deemed to have fallen vacant.

#### V. Preparation of Rank List

- (i) The percentage of marks obtained by the candidate in Part III and Part IV in all three years in the U.G. degree will be taken as the base mark for ranking for subject codes 01 to 10.
  - (ii) Candidates, who have taken more than one major subject in Part III (under Double/Triple major system) of U.G. Degree programme (Subject Codes 01 to 10) should choose only one of the major subjects. In such cases, marks obtained by the candidates in Two/Three major subjects shall be taken into account to arrive at percentage of marks as stipulated in Item II (ix).
  - (iii) The percentage of marks obtained by the candidates in the P.G. Degree will be taken as the base mark for ranking for the Subject Codes 11 to 19, subject to the condition that the major subject in the U.G. and P.G. Degrees shall be one and the same.
  - (iv) Candidates, who are qualified in the P.G. Degree (5 year integrated course) under 10+2+5 shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years in part III and part IV of the course alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4<sup>th</sup> & 5<sup>th</sup> year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.
  - (v) In case of determination of inter-se-merit of candidates with the same marks in the ranking, final ranking of candidates will be declared based on the following, in the order of merit.
    - a) Marks secured by the candidate in the Major subject.
    - b) Marks secured in Allied-I subject
    - c) Marks secured in Allied-II subject
    - d) By random method
  - (vi) Common and community wise rank list shall be maintained for each optional subject separately.

Weightage for the highest qualification in the same subject will be given as follows and added to the base mark for ranking. However, the minimum marks mentioned in the Item II (ix) is mandatory for subject codes 01 to 10 and not less than 50% of marks for subject codes 11 to 19.

  - b) NCC [B or C Certificate at college (U.G. degree) level]
  - c) Sports [should have represented the college (U.G. degree) at University/State/National level]

## VI. Cost of Application:

A candidate needs to submit only one application for B.Ed. Course seeking admission to Government and Government Aided Colleges of Education. The cost of application is Rs. 500/-. In the case of SC/ST candidates the cost of application is Rs. 250/- on production of attested Xerox copy of the Community Certificate. The cost of application must be paid either in cash or in the form of Demand Draft drawn from any Nationalised Bank / Scheduled Bank in favour of "The Secretary, Tamil Nadu B.Ed. Admission, Chennai", payable at Chennai.

#### VII. Important Instructions

- 1. The details provided by the candidates for admission shall be accurate based on the original certificates available with them. The candidate is totally responsible for any incorrect information and incorrect percentage of marks and such cases shall be summarily rejected.
- 2. Candidates are advised to take a Xerox copy of the coding sheet and fill up all the information correctly before filling the original coding sheet.

- 3. Candidates have to send the filled in applications (coding sheet-as loose sheet) along with the xerox copies of all Mark Sheets, Co-Curricular Activity Certificates and Community Certificate to "The Secretary, Tamil Nadu B.Ed. Admission, Lady Willingdon Institute of Advanced Study in Education, Chennai -600 005."
- 4. Candidates shall produce all the Original Certificates at the time of counselling for verification and admission or at any other time as required by the authorities. (i) Subject Codes 01 to 10: As these subjects are taught in the High School level, the requisite qualifications for admission to these subjects is U.G. Degree in the relevant subject with not less than the percentage of marks stipulated in Item II (ix) herein. The minimum Percentage of marks stipulated in Item II (ix) herein shall not be applicable to the candidates those who are having P.G. Degree in the same subject with not less than 50% of marks. But, the weightage for higher qualification given in clause V 2(i) (a) herein is not applicable for such candidates and the marks secured in P.G. Degree alone will be taken to arrive at rank.

(ii) Subject Codes 11 to 19: The requisite qualification for admission to these subjects is P.G. Degree in the relevant subject with not less than 50% of marks, subject to the condition that the major subject in the U.G. and P.G. Degree shall be one and the same.

iii) **Subject Codes 14 to 19:** The subjects indicated in these subject codes and **Urdu** are not offered by the Government and Government Aided Colleges of Education.

 Actual Major subjects offered in each college and number of seats available in respect of Government / Government Aided Colleges will be notified in the portal <u>www.tngasacdu.in</u> or at the Counselling Centre.

# II. Eligibility and Educational Qualification

(i) (a) Candidates with at least 50% of marks either in the Bachelor's Degree and/or in the Master's Degree in Science /Social Science /Humanities are eligible. Bachelor's Degree in Engineering or Technology with specialization in Science and Mathematics with 55% marks are also eligible for admission to B.Ed Degree programme.

(b) The candidates should have undergone 10+2+3(15) pattern of study and passed the qualifying examination conducted by the respective State Board or C.B.S.E. or any other recognized Board of Education / Examination and U.G. Degree Examination of the U.G.C. recognized Universities in any one of the school subjects offered by the Directorate of School Education at the Secondary/ Higher Secondary Education level.

(c) The three year Diploma in Engineering shall be treated as equivalent to +2 course for the purpose of eligibility for admission.

(ii) Candidates, who have passed the U.G. or P.G. Degree under Open University System without 10+2 pattern of School Education examination shall not be eligible for admission.

(iii) Candidates, who have taken more than one major subject in Part III & Part IV (under Double/Triple Major System) of U.G. degree course should have to choose only one of the major subjects and should have applied for that Major subject only. In such cases, marks obtained by the candidates in two/three major subjects shall be taken into account to arrive at the percentage of marks as stipulated in Item (ix) herein.

(iv) Candidates, who have passed any degree under Additional Degree Programme or lateral entry mode with less than three years of duration are not eligible for admission.

(v) Candidates, who have passed under four year Dual Degree Programme with two major subjects under Part III are not eligible for admission.

(vi) Candidates, who have qualified in the P.G. Degree in the subjects for the Codes 11 to 19 securing less than 50% of marks are not eligible for admission, subject to the condition that the major subject in the U.G. and P.G. Degrees shall be one and the same.

(vii) Candidates, who have qualified in the P.G. Degree (5 year integrated programme) under 10+2+5 pattern of study shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years in Part III and Part IV alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4<sup>th</sup> & 5<sup>th</sup> year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.

(viii) Equivalent Subjects

- (a) Candidates, who have done their U.G. degree in Applied Mathematics can apply for Mathematics.
- (b) Candidates, who have done their U.G. degree in Applied Theoritical Physics, Geo-Physics, Bio-Physics and Electronics can apply for Physical Science.
- (c) Candidates, who have done their U.G. degree in Applied Chemistry can apply for Physical Science.
- (d) Candidates, who have done their U.G. degree in Advanced Zoology and Bio-Technology, Plant-Biology and Plant Bio-Technology can apply for Biological Science.
- (e) Candidates, who have done their U.G. degree in Environmental Science and Micro-Biology can apply for Biological Science.
- (f) Candidates, who have done their U.G. degree in Applied Geography can apply for Geography.
- (g) Candidates, who have done their U.G. degree in Computer Science, Information Technology and Computer Application can apply for Computer Science.

- (h) Candidates, who have done their P.G. degree in Nutrition and Dietetics are eligible to apply for Home Science.
- (i) Candidates, who have done their U.G. degree in the school subjects (Subject Code 01 to 10) are eligible for admission to B.Ed. However, those who have done the U.G. in the subjects for which equivalence is not covered under the G.O. are not eligible for admission.
- (j) All the B.E./B.Tech. graduates irrespective of their Branch in Engineering/Technology are eligible to study either Mathematics or Physical Science as Pedagogy of a School Subject. However the B.E./B.Tech. graduates in Computer Science related branches and Bio-Technology related branches are also eligible to study Computer Science and Biological Science as Pedagogy of School Subject respectively. The reservation of seats for the graduates in B.E./B.Tech. in each Pedagogy of School Subjects (viz. Mathematics, Physical Science, Biological Science & Computer Science) shall be 5% only.
- (k) Candidates who have passed Bachelor's Degree in Engineering with not less than 3 years of duration under lateral entry are also eligible for admission.
- (ix) Candidates, with the following marks in the U.G. Degree are eligible for admission to B.Ed. degree programme with the Subject Code 01 to 10. The marks obtained in U.G. Degree alone shall be taken to arrive at the rank even if they possess P.G. Degree in the same subject. For the subjects with Subject Code 11 to 19, P.G. Degree with not less than 50% marks is mandatory and the subject in U.G. and P.G. shall be one and the same.

(a) Marks obtained by the candidates in the U.G. Degree Course in Part-III & IV [Tamil/Urdu, English, Mathematics, Physical Science (Physics), Physical Science (Chemistry), Biological Science (Botany), Biological Science (Zoology), History, Geography and Computer Science] alone shall be taken into account to arrive at the percentage of marks mentioned above. If the candidates possess higher degree in these subjects, weightage for the highest qualification will be given as mentioned herein under Item V 2 (i) only for arriving at rank.

- (b) Marks obtained by the candidates in the P.G. Degree [Home Science, Economics, Commerce, Political Science, Sociology, Psychology, Logic, Indian Culture, and Philosophy] shall be considered eligible for admission and weightage for the highest qualification will be given as mentioned herein under Item V 2 (i).
- (c) For the students who have done their Bachelors Degree in Engineering / Technology, the marks obtained in their Degree shall be taken into account.
- (d) Rounding of marks to the next higher integer shall not be permitted.
- (e) The candidates who are qualified in U.G. degree under Open University System after passing 10<sup>th</sup> Std. and +2 examinations shall alone be considered for admission to B.Ed. degree programme.
- (I) The candidates who are qualified in U.G. degree under Open University System without passing 10<sup>th</sup> Std. and +2 examinations and subsequently passing 10<sup>th</sup> Std. and +2 examinations are not eligible for admission to B.Ed. degree programme.
- (x) In the case of Differently abled (Physically and Visually challenged) candidates, a minimum pass in the requisite qualification is enough.

The basis of selection shall be in accordance with the Regulations of the University / Government of Tamil Nadu Guidelines for admission to B.Ed. degree programme in force from time to time.

#### III. Reservation of Seats

- 1. Reservation of seats for candidates belonging to BC, MBC/DNC, SC and ST communities will be made as per the rules and regulations of the Government of Tamil Nadu, as follows:
  - (a) 15% for Scheduled Castes (SC) and 3% for Scheduled Castes Arunthathiyars (SCA)
  - (b) 1% for Scheduled Tribes (ST)
  - (c) 20% for Most Backward Classes (MBC) and Denotified Communities (DNC)
  - (d) 26.5% for Backward Classes (BC) and 3.5% for Backward Classes Muslims (BCM)

- (c) 31% for Open Competition (OC)
- (f) 10 No. of seats shall be reserved in the single window counseling for the benefit of students of the Union Territory of Andaman and Nicobar under OC Category only.
- 2. Admission to every College of Education shall be made strictly by following the rule of reservation as per law in force including the Management quota scats of Non-Minority Aided Colleges.
- 3. For the Wards of Ex-Servicemen of Tamil Nadu origin, one seat will be reserved in each College of Education.
- 4. 5% of the sanctioned strength will be reserved for Differently abled (Physically and Visually challenged) students in each College of Education. Additionally, 5 seats are exclusively allotted for Visually Challenged candidates in each of the two IASEs and five Government Colleges of Education.
- 5. Allocation of seats in the Colleges of Education are grouped into the following categories:
  - Seats in Government Colleges of Education (100% of seats Government quota)
  - Seats in Government Aided Colleges of Education (50% of seats in Aided Minority Colleges and 90% of seats in non-minority Aided Colleges as Government quota)

### IV. Selection and Counselling

- 1. The Selection of candidates will be done purely on merit basis.
- 2. Candidate will not be considered for selection if he/she fails to report at the specified time and date for counselling with all the certificates in original.
- 3. At the time of counselling the candidates belonging to OC/BC/MBC/DNC category have to submit a Demand Draft for Rs. 2000/- and SC/ST category for Rs.1000/- as initial payment towards tuition fee. The DD should be drawn in favour of "The Secretary, Tamil Nadu B.Ed. Admission, Chennai". This amount will be adjusted towards the tuition fee.
- 4. The provisionally selected candidates have to join the allotted college within the date notified in his/her admission order, failing which his/her allotment will be cancelled and the seat will be deemed to have fallen vacant.

#### V. Preparation of Rank List

 (i) The percentage of marks obtained by the candidate in Part III and Part IV in all three years in the U.G. degree will be taken as the base mark for ranking for subject codes 01 to 10.

- (ii) Candidates, who have taken more than one major subject in Part III (under Double/Triple major system) of U.G. Degree programme (Subject Codes 01 to 10) should choose only one of the major subjects. In such cases, marks obtained by the candidates in Two/Three major subjects shall be taken into account to arrive at percentage of marks as stipulated in Item II (ix).
- (iii) The percentage of marks obtained by the candidates in the P.G. Degree will be taken as the base mark for ranking for the Subject Codes 11 to 19, subject to the condition that the major subject in the U.G. and P.G. Degrees shall be one and the same.
- (iv) Candidates, who are qualified in the P.G. Degree (5 year integrated programme) under 10+2+5 shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years in part III and part IV of the course alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4th & 5th year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.
- (v) In case of determination of inter-se-merit of candidates with the same marks in the ranking, final ranking of candidates will be declared based on the following, in the order of merit.

  - (c) Marks secured in Allied-II subject
  - (d) By random method
- (vi) Common and community wise rank list shall be maintained for each optional subject separately.

### VI. Cost of Application:

A candidate needs to submit only one application for B.Ed. Degree Programme seeking admission to Government and Government Aided Colleges of Education. The cost of application is Rs. 500/-. In the case of SC/ST candidates the cost of application is Rs. 250/- on production of attested Xerox copy of the Community Certificate.

## **VII.** Important Instructions

- Dates regarding online registration of application, payment of fee / uploading of certificates will be informed in the portal www.tngasaedu.in for Government and Government aided colleges. With regard to Self Financing colleges it will be informed in respective college website. No request for change of date/time of counselling is permissible.
- The details provided by the candidates for admission shall be accurate based on the original certificates available with them. The candidate is totally responsible for any incorrect information and incorrect percentage of marks and such cases shall be summarily rejected.
- Candidates are advised to take a Xerox copy of the coding sheet and fill up all the information correctly before filling the original coding sheet.



(Government / Government Aided / University Constituent / Self-Financing Colleges of Education)

# I. Major Subjects offered under B.Ed. Degree Programme

1. The following Major subjects are offered under B.Ed. Degree Programme in Government / Government Aided / University Constituent / Self-Financing Colleges of Education.

(i) **Subject Codes 01 to 10:** As these subjects are taught in the High School level, the requisite qualifications for admission to these subjects is U.G. Degree in the relevant subject with not less than the percentage of marks stipulated in Item II (ix) herein. The minimum Percentage of marks stipulated in Item II (ix) herein shall not be applicable to the candidates those who are having P.G. Degree in the same subject with not less than 50% of marks. But, the weightage for higher qualification given in clause V 2(i) (a) herein is not applicable for such candidates and the marks secured in P.G. Degree alone will be taken to arrive at rank.

(ii) **Subject Codes 11 to 19:** The requisite qualification for admission to these subjects is P.G. Degree in the relevant subject with not less than 50% of marks, subject to the condition that the major subject in the U.G. and P.G. Degree shall be one and the same.

iii) Subject Codes 14 to 19: The subjects indicated in these subject codes and Urdu are not offered by the Government and Government Aided Colleges of Education.

2. Actual Major subjects offered in each college and number of seats available in respect of Government / Government Aided Colleges will be notified in the portal <u>www.tngasaedu.in</u> or at the Counselling Centre.

# II. Eligibility and Educational Qualification

(i) (a) Candidates with at least 50% of marks either in the Bachelor's Degree and/or in the Master's Degree in Science /Social Science /Humanities are eligible. Bachelor's Degree in Engineering or Technology with specialization in Science and Mathematics with 55% marks are also eligible for admission to B.Ed Degree programme.

(b) The candidates should have undergone 10+2+3(15) pattern of study and passed the qualifying examination conducted by the respective State Board or C.B.S.E. or any other recognized Board of Education / Examination and U.G. Degree Examination of the U.G.C. recognized Universities in any one of the school subjects offered by the Directorate of School Education at the Secondary/ Higher Secondary Education level.

(c) The three year Diploma in Engineering shall be treated as equivalent to +2 course for the purpose of eligibility for admission.

(ii) Candidates, who have passed the U.G. or P.G. Degree under Open University System without 10+2 pattern of School Education examination shall not be eligible for admission.

(iii) Candidates, who have taken more than one major subject in Part III & Part IV (under Double/Triple Major System) of U.G. degree course should have to choose only one of the major subjects and should have applied for that Major subject only. In such cases, marks obtained by the candidates in two/three major subjects shall be taken into account to arrive at the percentage of marks as stipulated in Item (ix) herein.

(iv) Candidates, who have passed any degree under Additional Degree
Programme or lateral entry mode with less than three years of duration are not eligible for admission. (v) Candidates, who have passed under four year Dual Degree Programme with two major subjects under Part III are not eligible for admission.

(vi) Candidates, who have qualified in the P.G. Degree in the subjects for the Codes 11-to 19 securing less than 50% of marks are not eligible for admission, subject to the condition that the major subject in the U.G. and P.G. Degrees shall be one and the same.

(vii) Candidates, who have qualified in the P.G. Degree (5 yearintegrated programme) under 10+2+5 pattern of study shall be considered for admission. In such cases, the marks obtained by thecandidates in the first three years in Part III and Part IV alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks obtained by the candidates in the last two years (4th & 5th year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.

(viii) Equivalent Subjects

- (a) Candidates, who have done their U.G. degree in Applied Mathematics can apply for Mathematics.
- (b) Candidates, who have done their U.G. degree in Applied Theoritical Physics, Geo-Physics, Bio-Physics and Electronics can apply for Physical Science.
- (c) Candidates, who have done their U.G. degree in Applied Chemistry can apply for Physical Science.
- (d) Candidates, who have done their U.G. degree in Advanced Zoology and Bio-Technology, Plant-Biology and Plant Bio-Technology can apply for Biological Science.
- (e) Candidates, who have done their U.G. degree in Environmental Science and Micro-Biology can apply for Biological Science.
- (f) Candidates, who have done their U.G. degree in Applied Geography can apply for Geography.
- (g) Candidates, who have done their U.G. degree in Computer Science, Information Technology and Computer Application can apply for Computer Science.

- (h) Candidates, who have done their P.G. degree in Nutrition and Dietetics are eligible to apply for Home Science.
- (i) Candidates, who have done their U.G. degree in the school subjects (Subject Code 01 to 10) are eligible for admission to B.Ed. However, those who have done the U.G. in the subjects for which equivalence is not covered under the G.O. are not eligible for admission.
- (j) All the B.E./B.Tech. graduates irrespective of their Branch in Engineering/Technology are eligible to study either Mathematics or Physical Science as Pedagogy of a School Subject. However the B.E./B.Tech. graduates in Computer Science related branches and Bio-Technology related branches are also eligible to study Computer Science and Biological Science as Pedagogy of School Subject respectively. The reservation of seats for the graduates in B.E./B.Tech. in each Pedagogy of School Subjects (viz. Mathematics, Physical Science, Biological Science & Computer Science) shall be 5% only.
- (k) Candidates who have passed Bachelor's Degree in Engineering with not less than 3 years of duration under lateral entry are also eligible for admission.
- (ix) Candidates, with the following marks in the U.G. Degree are eligible for admission to B.Ed. degree programme with the Subject Code 01 to 10. The marks obtained in U.G. Degree alone shall be taken to arrive at the rank even if they possess P.G. Degree in the same subject. For the subjects with Subject Code 11 to 19, P.G. Degree with not less than 50% marks is mandatory and the subject in U.G. and P.G. shall be one and the same.

(a) Marks obtained by the candidates in the U.G. Degree Course in Part-III & IV *[Tamil/Urdu, English, Mathematics, Physical Science (Physics), Physical Science (Chemistry), Biological Science (Botany), Biological Science (Zoology), History, Geography and Computer Science]* alone shall be taken into account to arrive at the percentage of marks mentioned above. If the candidates possess higher degree in these subjects, weightage for the highest qualification will be given as mentioned herein under Item V 2 (i) only for arriving at rank.

- (b) Marks obtained by the candidates in the P.G. Degree [Home Science, Economics, Commerce, Political Science, Sociology, Psychology, Logic, Indian Culture, and Philosophy/ shall be considered eligible for admission and weightage for the highest qualification will be given as mentioned herein under Item V 2 (i).
- (c) For the students who have done their Bachelors Degree in Engineering / Technology, the marks obtained in their Degree shall be taken into account.
- (d) Rounding of marks to the next higher integer shall not be permitted.
- (e) The candidates who are qualified in U.G. degree under Open University System after passing 10th Std. and +2 examinations shall alone be considered for admission to B.Ed. degree programme.
- (f) The candidates who are qualified in U.G. degree under Open University System without passing 10th Std. and +2 examinations and subsequently passing 10th Std. and +2 examinations are not eligible for admission to B.Ed. degree programme.
- (x) In the case of Differently abled (Physically and Visually challenged) candidates, a minimum pass in the requisite qualification is enough.

The basis of selection shall be in accordance with the Regulations of the University / Government of Tamil Nadu Guidelines for admission to B.Ed. degree programme in force from time to time.

#### III. **Reservation of Seats**

/

1. Reservation of seats for candidates belonging to BC, MBC/DNC, SC and ST communities will be made as per the rules and regulations of the Government of Tamil Nadu, as follows:

- 15% for Scheduled Castes (SC) and 3% for Scheduled Castes (a)Arunthathiyars (SCA)
- 1% for Scheduled Tribes (ST) (b)
- 10.5% for Most Backward Classes [MBC(V)] 7% Denotified (c)Communities MBC/(DNC) and 2.5% MBC others.

- 26.5% for Backward Classes (BC) and 3.5% for Backward (d) Classes Muslims (BCM)
- (e) 31% for Open Competition (OC)
- 10 No. of seats shall be reserved in the single window counseling for the benefit of students of the Union Territory of Andaman (1) and Nicobar under OC Category only.
- 2. Admission to every College of Education shall be made strictly by following the rule of reservation as per law in force including the Management quota seats of Non-Minority Aided Colleges.
- 3. For the Wards of Ex-Servicemen of Tamil Nadu origin, one seat will be reserved in each College of Education.
- 4. 5% of the sanctioned strength will be reserved for Differently abled (Physically and Visually challenged) students in each College of Education. Additionally, 5 seats are exclusively allotted for Visually Challenged candidates in each of the two IASEs and five Government Colleges of Education.
- 5. Allocation of seats in the Colleges of Education are grouped into the following categories:

(i) Scats in Government Colleges of Education (100% of seats

Government quota) (ii) Seats in Government Aided Colleges of Education (50% of seats in Aided Minority Colleges and 90% of seats in non-minority Aided Colleges as Government quota)

#### Selection and Counselling IV.

1. The Selection of candidates will be done purely on merit basis.

- The date, time and venue of the counselling will be published in the website / press / media. No request for change of date 2. i) / time of counselling is permissible.
  - ii) Candidate will not be considered for selection if he/she fails to report at the specified time and date for counselling with all the certificates in original.
  - At the time of counselling the candidates belonging to OC/BC/MBC/DNC category have to submit a Demand Draft for Rs. 2000/- and SC/ST category for Rs.1000/- as inital payment 3. towards tuition fee. The DD should be drawn in favour of "The Secretary, Tamil Nadu B.Ed. Admission, Chennai". This amount will be adjusted towards the tuition fee.

- Candidates, who have taken more than one major subject in (ii) Part III (under Double/Triple major system) of U.G. Degree programme (Subject Codes 01 to 10) should choose only one of the major subjects. In such cases, marks obtained by the candidates in Two/Three major subjects shall be taken into account to arrive at percentage of marks as stipulated in Item II
- (iii) The percentage of marks obtained by the candidates in the P.G. Degree will be taken as the base mark for ranking for the Subject Codes 11 to 19, subject to the condition that the major subject in the U.G. and P.G. Degrees shall be one and the
- (iv) Candidates, who are qualified in the P.G. Degree (5 year integrated programme) under 10+2+5 shall be considered for admission. In such cases, the marks obtained by the candidates in the first three years in part III and part IV of the course alone shall be taken into account for admission to the B.Ed. Degree programme for subject codes 01 to 10. The marks by the candidates in the last two years (4th & 5th year) alone shall be taken into account for admission to B.Ed. degree programme for subject codes 11 to 19.
- In case of determination of inter-se-merit of candidates with the (v) same marks in the ranking, final ranking of candidates will be declared based on the following, in the order of merit.
  - (a) Marks secured by the candidate in the Major subject.
  - (b) Marks secured in Allied-I subject

- Common and community wise rank list shall be maintained for (vi) each optional subject separately.

(ii) Weightage of 3 (three) marks for participation in any one of the following co-curricular activities will be added.

- (a) NSS [with two years enrolment in NSS and with a minimum of seven days participation in the Special Camp at College (U.G. degree) level alone will be considered]
- (b) NCC [B or C Certificate at college (U.G. degree) level]
- (c) Sports [should have represented the college (U.G. degree) at University/ State/National level]

#### VI. Cost of Application:

A candidate needs to submit only one application for B.Ed. Degree Programme seeking admission to Government and Government Aided Colleges of Education. The cost of application is Rs. 500/-. In the case of SC/ST candidates the cost of application is Rs. 250/- on production of attested Xerox copy of the Community Certificate.

#### **VII.** Important Instructions

- Dates regarding online registration of application, payment of fee / uploading of certificates will be informed in the portal www.tngasaedu.in for Government and Government aided colleges. With regard to Self Financing colleges it will be informed in respective college website. No request for change of date/time of counselling is permissible.
- 2. The details provided by the candidates for admission shall be accurate based on the original certificates available with them. The candidate is totally responsible for any incorrect information and incorrect percentage of marks and such cases shall be summarily rejected.
- Candidates are advised to take a Xerox copy of the coding sheet and fill up all the information correctly before filling the original coding sheet.
- Candidates have to effect online payment of Rs.500/- for general candidates, Rs.250/- for SC/ST candidates and upload certificates in the portal.

- 5. Candidates shall produce all the Original Certificates at the time of counselling for verification and admission or at any other time as required by the authorities. Selection will not be made if they do not produce the relevant and original documents at the time of counselling for verification.
- 6. The candidates belonging to Tamil Nadu only will be considered for communal reservation. Candidates seeking admission against SC, SC(A), ST, MBC(V), MBC/DNC, MBC (others), BC (Muslim) and BC (others) quota should obtain the Certificate of Social Status in the prescribed permanent Community Certificate / Card of Tamil Nadu and that should be produced at the time of counselling.
- 7. The ST candidates should obtain the Community Certificate only from the Revenue Divisional Officer (RDO) of their native place or
